Overview

Unused openings in boxes, raceways, auxiliary gutters, cabinets, equipment cases, or housings shall be effectively closed to afford protection substantially equivalent to the wall of the equipment. Working space: The front clearance, side clearance, and height clearance requirements for electrical equipment that provide a safe area for maintenance, inspections, and other work. This includes pad-mount, subsurface, and vault installations with or without equipment. Electric equipment shall be free from recognized hazards that are likely to cause death or serious physical harm to employees. Safety of equipment shall be determined using the following considerations: Suitability for installation and use in conformity with the provisions of this subpart; Note to. 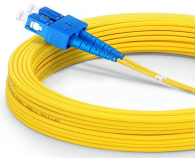
One common characteristic of the equipment types covered in this section is that they are all enclosed for safety.
