Connector quality itself may also be at fault, particularly if end-face geometry doesn't meet the IEC PAS 61755-3 standards. Fiber optic networks are celebrated for their speed and reliability, but even the best systems can encounter problems.

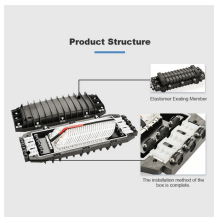
