1993 NEC Section 300-7 (b) states that “Raceways shall be provided with expansion joints where necessary to compensate for the thermal expansion or contraction. ” In 1993 NEC Article 318 there are no requirements for the handling of the thermal contraction and expansion of cable. Connecting cable trays correctly is essential for system safety, load stability, and long-term performance. 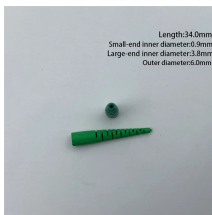
Cable trays are common in industrial and commercial environments because they allow easy cable additions, removals, and inspection without pulling through conduit.
