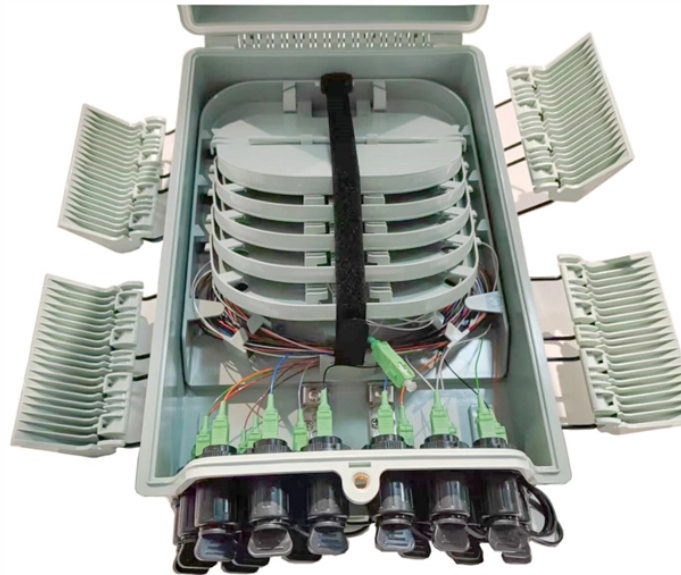


## Regulations Regarding Distribution Boxes



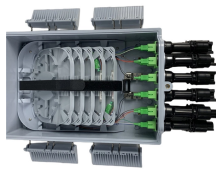
### Overview

Federal acts, such as the Fair Packaging and Labeling Act and the Poison Prevention Packaging Act, remain central to compliance. States tighten rules with Extended Producer Responsibility (EPR) and recycled content requirements. An individual covering, carton, or other container of the bottle used for sale at retail (other than a shipping container), may not contain any statement, design, device, or graphic, pictorial, or emblematic representation that is prohibited on labels by regulations in subpart F, G, or H of this. Effective April 5, 2012, the Postal Service™ will revise Postal Operations Manual (POM) subchapters 61, 63, 64, and 65 in selected subsections to provide updated and revised information and procedures regarding modes of delivery and delivery equipment.
