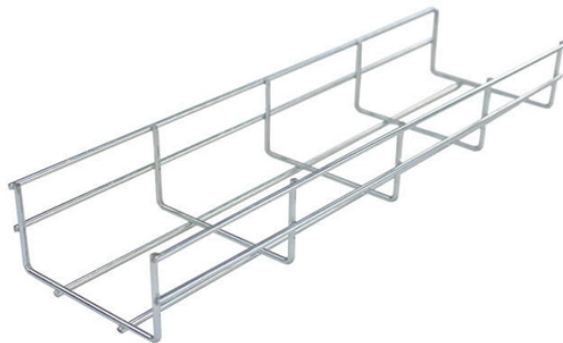


# Requirements for Homogeneous Communication Optical Cables and Cables
