TL;DR: The **\*\*HS code for spectrometers\*\*** is 9027. 30 in 2025, covering UV-Vis, IR, and other optical types. On February 20, 2026, the President issued Executive Order 14389, "Ending Certain Tariff Actions," which provides that certain additional ad valorem duties imposed under the International Emergency Economic Powers Act (IEEPA) will no longer be collected. 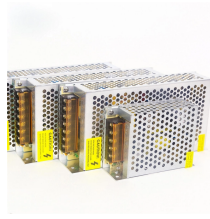
